Aims:

The seminar offers participants the opportunity to:

- Share their analysis of the impact of national and international economic and political decisions on concrete living and working conditions,
- Exchange information and experience of concrete actions in diverse contexts,
- Discover resources of faith, theology and spirituality as the basis for new and promising strategies and
- Explore new approaches for change and renewal.

Through this process of exchange, analysis and theological reflection we are looking for new ways of local, national and international action that can be supported by different people and groups.

Programme:

Key Questions:

- Where do we see increasing debt and modern slavery in practice?
- Where do we see the practice of redemption and liberation?
- How does theology serve to legitimate debt(s) and enslavement?
- How does theology support and empower resistance?
- What encouraging practice has been developed? Are we developing? Could we develop?

Context, Reality und Actions:

We begin with the concrete reality of people living everyday with indebtedness, with the dynamics of debt and the ways towards freedom from debt. We will look at the impact of the financial crisis and debt on the countries of southern and eastern Europe through analysis and the experience of those affected.

The Austrian reality will be used as a ,mirror' for the reflections of the experience of the participants. The focus is on listening and conversation.

Theology and Spirituality:

Starting from the Bible leads us to develop counter-proposals to an economy of debt and exclusion. Together we will concretise a liberating theology for Europe.

A good life and good work for all is the vision and the direction of action.

We will reflect on our own practice and what has been experienced and learnt from our common experience and plan for future actions.
